During the year, the Art Museum purchased renovation capital assets totaling approximately \$3,026,000 which was transferred to the Columbia Museum of Art Commission.

The Museum holds more than 7,000 art objects covering all periods of history from ancient through modern. The value of art objects purchased by the Museum or donated to the Museum is not included within its statement of financial position as they are held for public education and exhibition, are protected and preserved, and the proceeds from the sale of collection items are used to acquire other items for the collection.

The Museum's collection is comprised of paintings, paper, sculpture, furniture, glass, ceramics, decorative art and design that falls into four broad categories: American Art, European Art; Contemporary; and Asian Art.
